LACW August Meeting

1. ACB Update:

- a. We need to get moving on with the committees.
 - i. They need the lists with the task lists on them. (These were sent to the executive committee via email.)
- b. Jim Caneen from the ACB national office said that we can charge for a “special event” concert.
 - i. Contacted the manager for the Canadian Brass to see if they could perform at ACB and other details.
- c. Trying to ask for permission on the usage of the Zia symbol for the ACB 2021 logo.
- d. Paul Lewis needs content for the website.
 - i. Current content:
 1. Logos on each band.
 2. Page for venues.
 3. No information on guest artists yet.
- e. Need to create a mail merge with “save the date” information. This should be sent to each band/individual on the .csv that was sent to the executive committee via email. Heidi (secretary of NM ACB) should do this.
- f. Need confirmation letter from the government that confirms our tax-exempt status.
- g. Finance committee will be separate from fundraising.
 - i. Bylaws should be consulted about the proposed separation.
- h. Adoption of communication software?
 - i. So far, monthly meetings have worked out well for the planning committee.
 - ii. Each band is in charge of two committees (those are not shared responsibilities). There are two shared committees also (Hospitality and Finance/Fundraising).
- i. Lencic costs. Potentially up to \$5,200.
